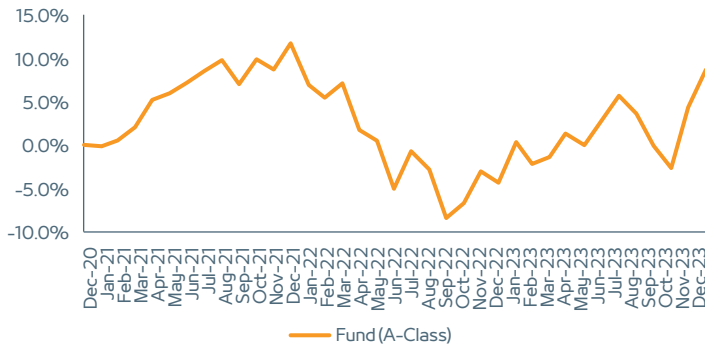

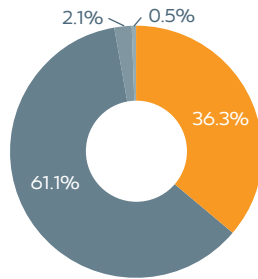
Performance Chart



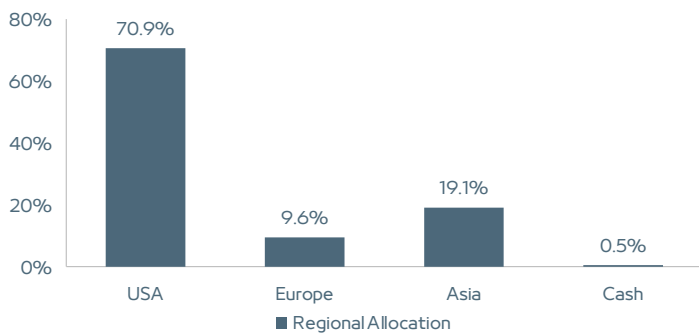

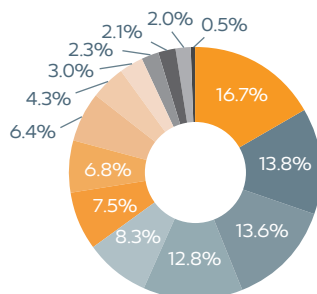

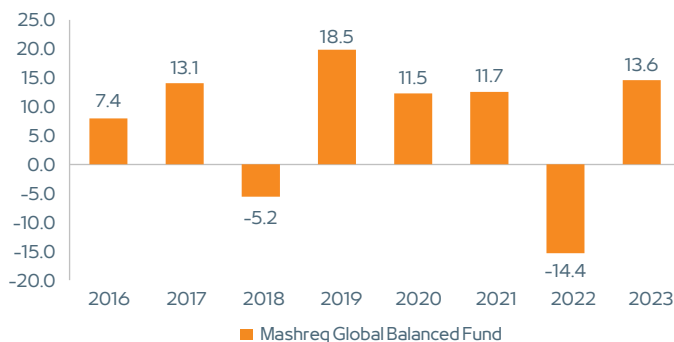
