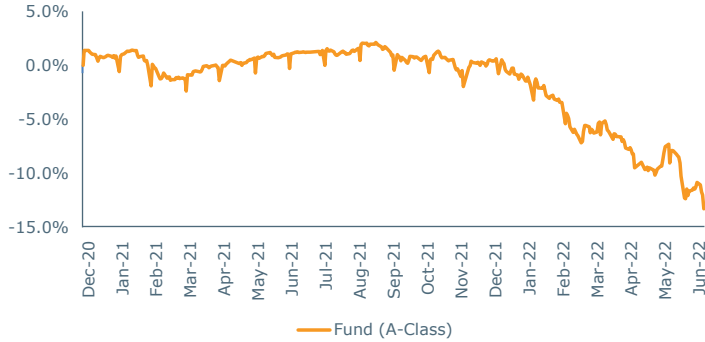

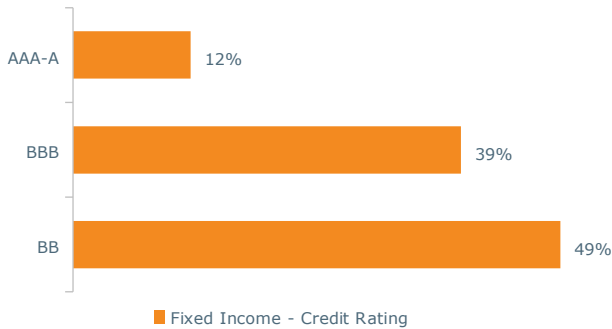

**Asset Allocation**



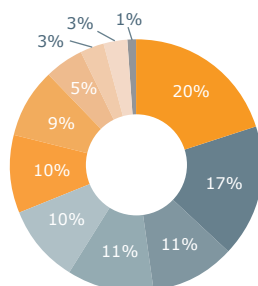

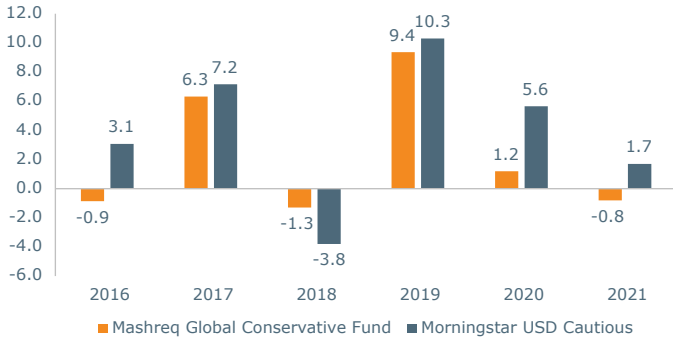

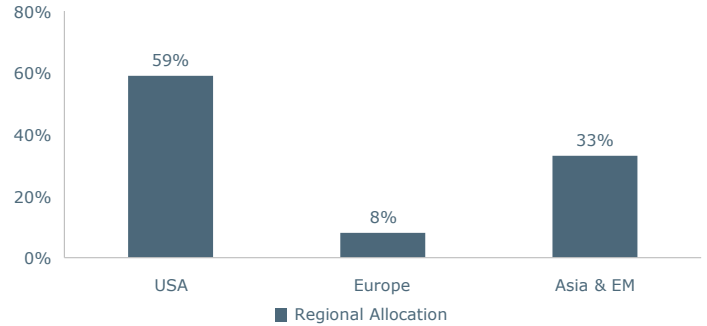
