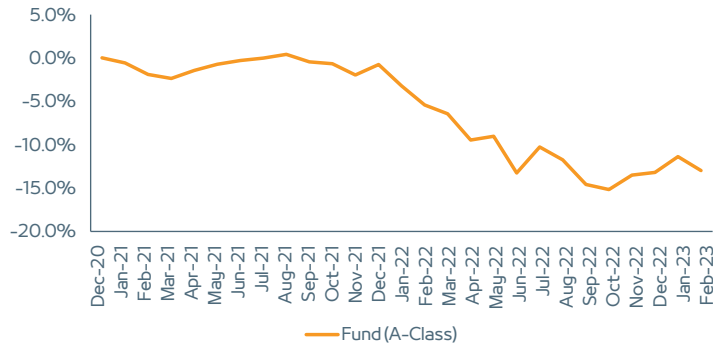

Performance Chart

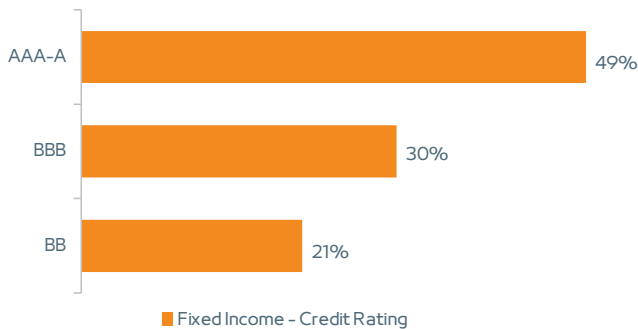

Asset Allocation



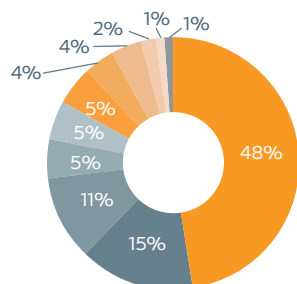
Fixed Income - Credit Rating

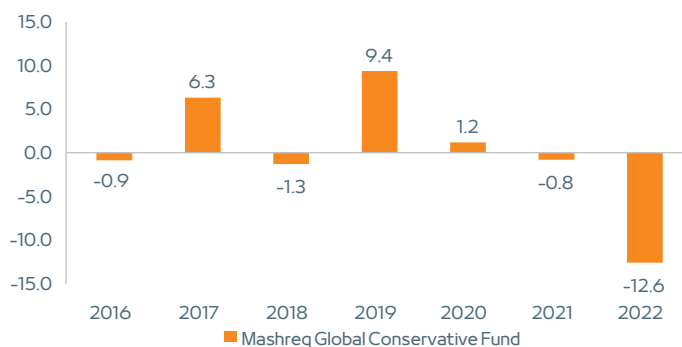

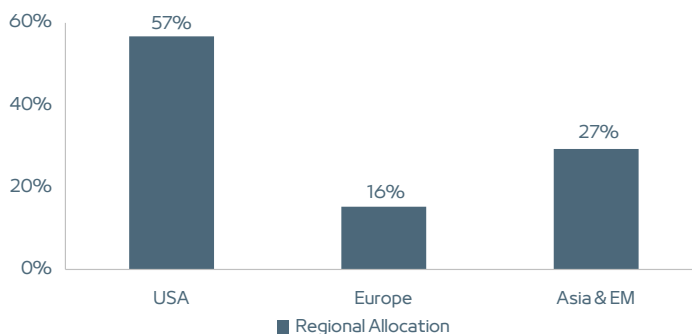
