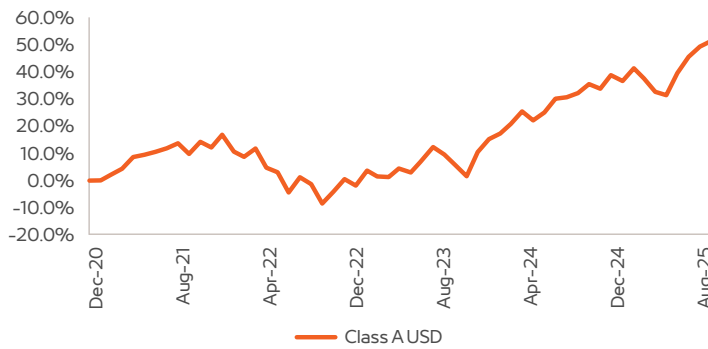

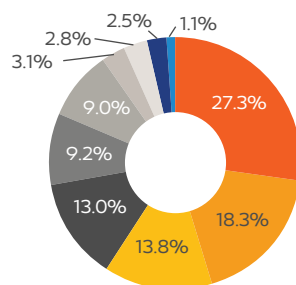

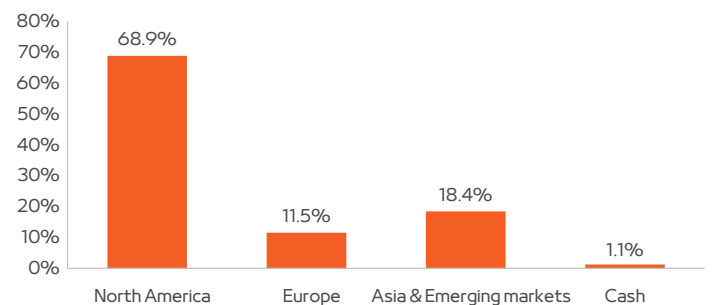

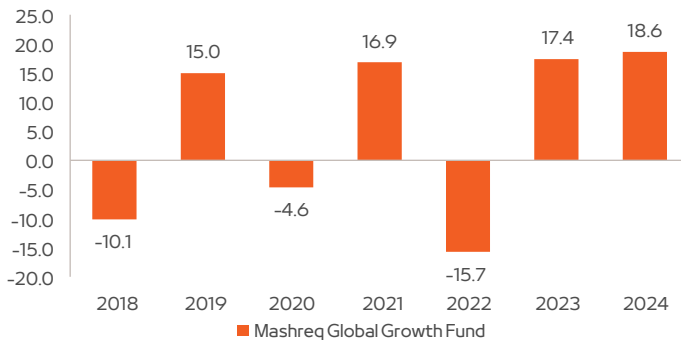


Regional Allocation
