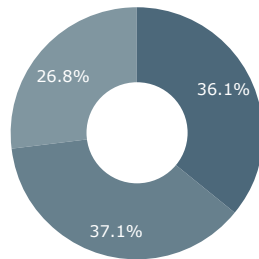

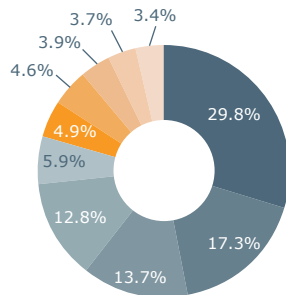
Maturity Profile

- 20+ Years (26.8%)



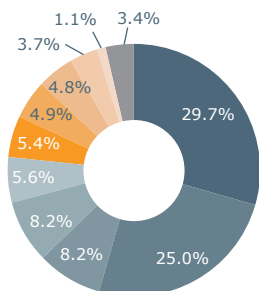

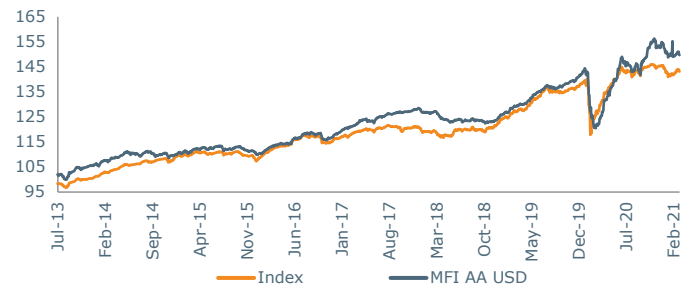
