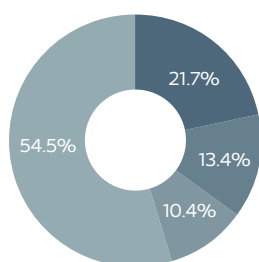

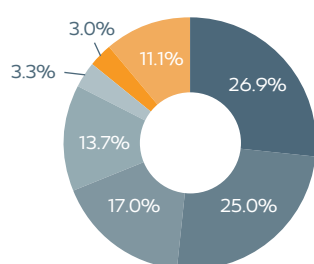
Maturity Profile

- 20+ yrs (54.5%)



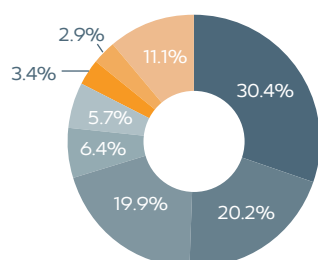
Industry Allocation

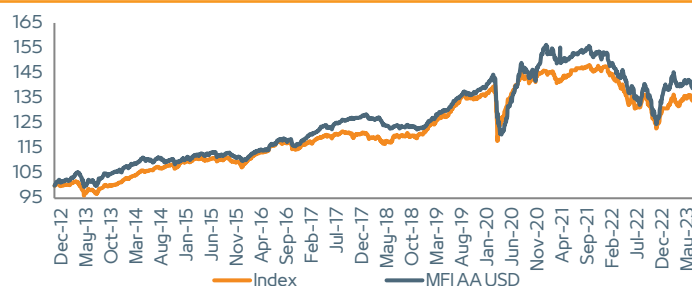


Regional Allocation
